Introduction

The National Specialty Society for Community Medicine (NSSCM), in partnership with the Canadian Public Health Association (CPHA) and the Association des médecins spécialistes en santé communautaire du Québec (AMSSCQ), is pleased to present their first ever continuing professional development symposium. Themed, *"Making it Happen: The Role of the Public Health Physician in the Development of Public Health Policy,"* this accredited symposium will be held at the Westin Ottawa, Provincial Room I, on Sunday, September 16, 2007 from 12:00 - 15:40.

Overview

Public health physicians play a major role in the development and implementation of public health policy in Canada. Emerging issues are demanding a collaborative and strategic approach to policy development. This symposium will provide insight in creating strategies to develop and implement public health policy in Canada. This half-day will explore current initiatives and strategies for public health policy implementation, will define policy initiatives on specific emerging public health topics, and will include interactive discussions on policy implications and setting the framework for strategy development. The session will close with a discussion of further steps for the NSSCM to pursue continuing professional development (CPD) on public policy analysis.

Symposium Objectives

1. Gain an understanding of the basic principles of public health policy development, including the elements of successful implementation.
2. Identify the main challenges and obstacles faced by public health physicians when developing and/or implementing public health policy.
3. Identify frameworks and tools to use for public policy analysis.
4. Begin to formulate a strategy for the NSSCM for future continuing education on public policy analysis.

Who Should Attend

This symposium will be of interest to community medicine specialists, public health physicians, family physicians working in or with an interest in public health and public health policy and general public health professionals working in policy development and implementation.

Opening Remarks

12:35 – 12:45

Dr. David Butler-Jones, Canada's first Chief Public Health Officer, heads the Public Health Agency of Canada, providing leadership on the government's efforts to protect the health and safety of Canadians. Dr. Butler-Jones brings to the position an extensive background in public health and has recently served as the Medical Health Officer for Sun Country Health Region and Consulting Medical Health Officer for the Saskatoon Health Region in Saskatchewan. He is also an Associate Clinical Professor with the Faculty of Medicine at the University of Saskatchewan and has taught at both the undergraduate and graduate levels. Dr. Butler-Jones is presently the co-chair of the newly established Pan-Canadian Public Health Network.

Introduction to Policy Analysis

12:45 – 13:05

Dr. Michael Rachlis currently practices as a private consultant in health policy analysis. He has consulted to the federal government, all ten provincial governments, and two royal commissions. He also holds an associate professor appointment (part-time) with the University of Toronto Department of Health Policy, Management, and Evaluation. He has lectured widely on health care issues and has been invited to make presentations to committees of the Canadian House of Commons and Senate and the United States House of Representatives and Senate. Dr. Rachlis is a frequent media commentator on health policy issues and the author of three national bestsellers about Canada's health care system.

Harm Reduction – The Vancouver Safe Injection Site

13:05 – 13:20

The opening of North America's first supervised injection facility in Vancouver, BC in 2003 brought with it great hopes and fueled an even greater debate which continues today. Safe injection policy development occurs in all areas, from the liability issues for the staff working within the site, to addressing international treaties. Dr. Perry Kendall identifies approaches to safe injection site policy development and provides insight in addressing this politically charged subject.

Dr. Perry Kendall has devoted his professional life to promoting and pursuing innovative health care practices in British Columbia. His efforts have focused on the prevention of disease, injury and disability, and the promotion of population health. Dr. Kendall is a former Medical Health Officer for the City of Toronto and a former CEO of the Addiction Research Foundation of Ontario. He is considered to be one of Canada's leading authorities on public health and drug addiction. He was co-chair of the task group on the feasibility of Supervised Injection Site Research. He was also instrumental in developing needle exchange programs and Canada's first safe injection site in Vancouver in 2003. Dr. Kendall is presently the Provincial Health Officer for the province of British Columbia and the co-chair of the newly established Pan-Canadian Public Health Network.

Pandemic Influenza

13:20 – 13:35

The risk of influenza pandemic is one of the most prominent global health threats at this time. Influenza pandemic would place a tremendous strain on the health system and have severe societal impacts. The complexity of policy development for influenza pandemic demands a co-ordinated inter- and intra-governmental response. Dr. Arlene King will illustrate pandemic influenza policy initiatives used to create proactive plans and strategies towards implementing an effective response effort.

Dr. Arlene King is the Director General for the Emergency Preparedness Secretariat for the Public Health Agency of Canada. She was Medical Officer of Health in Vancouver and Burnaby, British Columbia, and was Provincial Epidemiologist at the British Columbia Centre for Disease Control in Vancouver. She has been with Health Canada since 1999. Her interests include national and international program and policy development, surveillance and outbreak investigations. She is currently a member of the WHO-AFRO Region Polio Eradication Certification Commission.
