The EMD/MHO will serve as a Medical Health Officer (MHO) for a community in addition to leading Population & Public Health wide surveillance and EDI initiatives. Working closely with Medical Health Officers, operational Directors, Managers and other partners, the EMD/MHO will oversee a wide variety of legislative and non-legislative initiatives that promote and protect public health for the assigned area.

The Executive Medical Director/Medical Health Officer of Population and Public Health will be a clear, caring, and courageous leader who will develop and promote medical standards, education and research, and manage the organization and effectiveness of medical staff within the program.



The EMD/MHO will communicate a shared vision internally and will simultaneously champion a multi-faceted approach to knowledge translation and program evaluation initiatives that are vital to quality community and population health outcomes. By cultivating partnerships across FH and with decision making bodies in the community, senior levels of Government, the private sector, other health authorities and multi-sectoral groups, the EMD/MHO will influence policy to improve health status while advancing program-wide quality, performance monitoring and evaluation, health equity, and population health strategies.

The successful candidate will have:

- Medical Doctor degree with current licensure with the College of Physicians and Surgeons of British Columbia in Public Health and Preventive Medicine (FRCP(C));
- Ten (10) years of recent related experience involving responsibility in medical leadership, public health, operational and strategic planning;
- Proven skills in managing financial and human resources;
- Current BC Driver's License and access to personal vehicle for business-related purposes;
