The Deputy Chief will be highly collaborative and fully embrace the dyad model of joint informed planning. They will demonstrate diplomacy, negotiation, and strong interpersonal skills to develop networks and partnerships with one or more of public health, research, academic, and institutional sectors, to manage critical relationships internally and externally (with clients and stakeholders) and to build networks to negotiate opportunities and resolve conflict. They will hold a valid College of Physicians and Surgeons of Ontario independent practice license in infectious diseases or public health and preventive medicine and an academic appointment at the rank of assistant professor or higher (or eligibility for and willing to obtain) is required. The ideal candidate will bring ten (10) years' experience as a senior leader in a public health or related setting either at a local or provincial agency, a not-for profit organization and/or government ministry. They will also bring five (5) years' public health work experience with strong knowledge and practice of public health in relation to communicable and infectious diseases in the community. They will have knowledge of, and skills in Health Protection with considerable breadth of knowledge development of the complex public health field to act as an authority in the subject area.
