Senior Resident Re-entry Position, Public Health & Preventive Medicine Program (ROS) updated January 15, 2024

General Information

The UBC Public Health & Preventive Medicine (PHPM) Residency Program is looking for candidates to fill *two* senior post-graduate year three (PGY-3) re-entry residency position, *available July 1, 2024*. There is some flexibility with start dates (before or after), however an estimated start date must be declared by interested candidates in their application materials.

Following completion of the residency program a *Return-Of-Service (ROS)* in B.C. is required (location determined by the Ministry of Health during residency). Program Information

Based out of UBC's Point Grey campus in Vancouver for the first year, our PHPM program draws on training sites around the province including Richmond, Burnaby, Surrey, Victoria, Nanaimo, Kelowna, and Prince George. *Re-entry residents will complete three years of training in PHPM* including 12-months of graduate course work leading to a Master of Public Health, 12-months of general public health practice, and 12-months of specialty public health practice. Residents have the option of completing up to 28 months of their senior residency training outside of BC's Lower Mainland.

At the end of the post-graduate training program residents are eligible to sit examinations for fellowship with the Royal College of Physicians & Surgeons of Canada. Information about our residency program can be found at: https://www.spph.ubc.ca/programs/residency-program/

Eligibility

Candidates must be fully qualified generalist or specialist physicians *currently practicing in Canada under a full family practice or specialty class license* with a provincial Medical Regulatory Authority (Canadian or International Medical Graduates are eligible IF they have a current full license to practice in a province of Canada). Candidates must have completed at least *two years of an accredited post-graduate residency training program* recognized by the Royal College of Physicians & Surgeons of Canada or the College of Family Physicians of Canada. Candidates must have been in active clinical practice for a minimum of 12 months following completion of prior post-graduate residency training. Candidates must meet the same criteria that are applied to those candidates who successfully match through CaRMS, including a comprehensive file review and panel interview. Candidate Attributes

Successful candidates will have demonstrated:

- Commitment to and interest in public health and preventive medicine
- Conscientiousness, reliability, dependability, and organization skills
- Service orientation, social conscience, and compassion
- Understanding of and experience with equity, diversity, and inclusion

- Initiative and desire to learn
- Stress tolerance, resilience, and adaptability
- Teamwork, social and interpersonal skills, communication skills
- Integrity and strong ethics

Application Process

UBC's PHPM re-entry ROS residency positions are offered on a competitive basis by application outside of the Canadian Residency Matching Service (CaRMS) process. Our Selections Committee will accept application packages from interested candidates at any time during the calendar year. Only shortlisted candidates will be contacted and offered an interview by the PHPM program Selections Committee. *An introductory meeting with the Program Director prior to applying is strongly recommended (email spph.residency@ubc.ca to schedule an appointment)*.

A complete application package will consist of the following:

- Cover Letter or Personal Statement discussing professional aspirations, interests, and suitability for practice in PHPM (maximum two pages). Applicants are invited to comment on their 'distance travelled' (journey as a member of an equity deserving group), advocacy in health equity, community leadership, and scholarship as appropriate and where relevant.
- Curriculum Vitae including post-graduate residency training, relevant continuing professional development, prior employment, prior medical staff appointments, community-based volunteer or international work, research activities and publications.
- 3. *Description of Prior Residency Training* including details such as dates and duration of rotations, and any requirements for remediation over the course of this training.
- 4. Three Letters of Reference including one from an established physician (preferably a public health practitioner) who can speak to the applicant's interest in and aptitude for public health, AND a health authority (or equivalent) senior medical director or hospital chief of staff. The letters should include information similar to that required by CaRMS which can be found at: https://www.carms.ca/match/r-1-main-residency-match/referee/reference-guidelines-r1 -referee/.
- 5. Proof of Registration and Licensure with a Canadian provincial Medical Regulatory Authority
- 6. Proof of Registration as a Licentiate of the Medical Council of Canada

Note: Official transcripts for all post-secondary training including but not limited to undergraduate, post-graduate, and medical school programs (eg. BSc, MD, MB, BS, MSc, PhD, etc.) will be required 2 months prior to a successful applicant's start date.
